All topsoil to BS 3882:2015 Specification for topsoil and all subsoil to BS8601 2013 British standard for Subsoil

Refer to arboriculturalist information for details of existing trees and vegetation.

All tree locations to be reviewed at the detailed design stage with service locations.

HARD LANDSCAPE

- Granite/granite style block. E.g. Marshall's Modal, 300x100mm, Charcoal, Silver and Mid grey
- Granite/granite style block. E.g. Marshall's Modal, 400x300mm, Charcoal, Silver and Mid grey
- Granite/granite style block. E.g. Marshall's Modal, 400x300mm, Charcoal, Silver and Mid grey
- Resin bound gravel, three colours in yellow/light brown tones
- Composite decking. E.g. Milboard, Enhance Grain, Golden oak or similar and approved
- Vitrified clay paving to private terraces E.g. Marshall's Symphony, 20mm thickness, natural - Ivory colour or similar approved
- Asphalt with rolled aggregate finish to car park and car park access
- Existing blacktop, to be retained and made good
- Tactile paving
- Granite/granite style slab. E.g. Marshall's Modal, 600x200mm, Anthracite and Silver grey
- Play safety surfacing, bound rubber bark mulch, red/yellow/brown tones or similar approved
- Granite setts with rumpled strip/area, mid grey colour
- Steps with textured concrete step unit E.g. Marshall's Perfecta, Natural colour with contrasting band or similar approved

EDGING

- Edge Type 1 - 200mm wide x 125mm high raised kerb, granite/granite style, silver grey colour.
- Edge Type 2 - 3mm wide flexible metal edging. E.g. Kinley's AluExcel or similar approved
- Edge Type 3 - 6mm metal edging raised planter. E.g. CorTen steel, Kinley's HiGrade Bespoke or similar approved

STREET FURNITURE

- Proposed bench
- Proposed litter bin
- Proposed bollard
- Proposed lighting
- Cycle stand for parking both sides

PLAY AREA

- Proposed informal play area with simple timber play equipments (e.g. balancing beam, stepping post...) and playable elements (e.g. boulders, logs...)
- Proposed formal play area with timber play equipment and safety surfacing

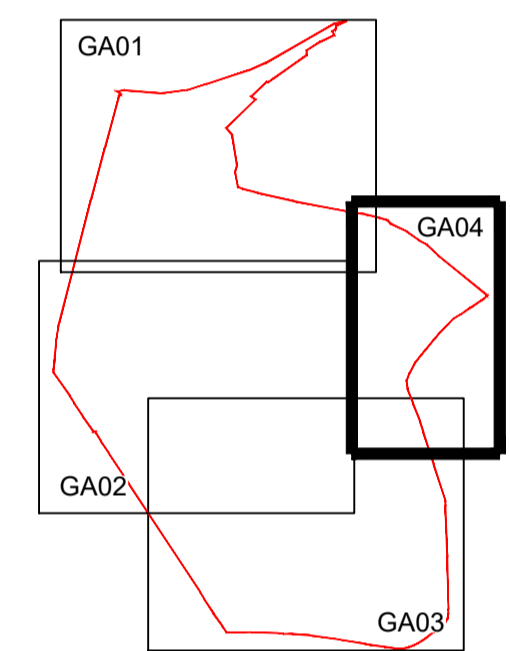
Note:

The detail design is to incorporate tactile paving to meet the British Standard. Road crossing are to be advised by the project traffic engineer.

Lighting details to be coordinated engineer's detail.

Boundary treatment and gates to private terraces to tie in with architectural detail.

All kerbs to be BS standard kerbs.
